



## CAMPING REGULATIONS UEC EUROPEAN CUP 7&8 TIEL (NLD)

TFCC De Weirijders welcomes you to its campsite during the weekend of May 30 & 31 and June 1, 2025! To ensure a pleasant BMX weekend for everyone, we have established a set of rules.

Misconduct and vandalism will be strictly addressed. The TFCC De Weirijders board reserves the right to deny access to the campsite and the BMX venue.

After 23h00, silence must be maintained on the campsite so that all BMX riders can enjoy their necessary rest.

We expect everyone to adhere to these regulations to guarantee a safe and enjoyable stay for all.

### 1. Reservations

- **Online booking:** a camping spot must be reserved online in advance, as the number of spots is limited. On-site reservations are not possible.
- **Dimensions:** ensure you book the correct camping spot size as indicated in the online reservation form. If your camping equipment differs in size from the reserved spot, your reservation may be cancelled upon arrival. No refunds will be issued.
- **Group reservations:** if you wish to camp next to others (with identical-sized equipment), you must book multiple spots in one reservation.
- **Water & electricity:** there are no water connections and no electricity available at the camping spots.

### 2. Arrival and departure

- **Arrival:** guests must arrive within the reserved/allocated time slots. Upon arrival, you will receive a colour code corresponding to your camping spot.
- **Parking:** park your car, caravan or camper according to the instructions of the parking and camping staff.
- **Departure:** on Sunday June 1<sup>st</sup> 2025, all guests must have left the campsite by 22h00 at the latest.

### 3. Sanitary facilities

- **Toilets:** toilets are available on the campsite (see map upon arrival). Washbasins are also available.
- **Showers:** showers are available on the campsite (see map upon arrival).

### 4. Safety

- **Open fires:** open fires are strictly prohibited throughout the premises.
- **Fire extinguishers:** every caravan/camper must be equipped with a properly approved fire extinguisher.
- **Gas bottles:** gas bottles must comply with applicable safety standards and periodic inspections.
- **Scooters & mopeds:** riding scooters and mopeds on and around the campsite/BMX venue is prohibited.
- **Maximum speed:** vehicles must drive at walking pace on the campsite (max. 5 km/h).

### 5. Camping equipment

- **Awnings and canopies:** the use of awnings is not permitted. Canopies are allowed as long as they remain within the boundaries of your designated camping spot.

### 6. Pets

- **Allowed:** pets are permitted on the campsite.
- **Clean-up obligation:** pets must be walked on the grassy area outside the premises. A grass field is available next to the cycle path on Schaarsdijkweg. Owners are obliged to clean up their pets' feces immediately.

### 7. Waste management

- **Waste disposal:** deposit waste in the designated bags and bins.
- **Clean up obligation:** ensure that your camping and parking area remains tidy and is left clean.

### 8. Camping outside designated areas:

- It's prohibited to place camping equipment outside the designated areas.
- The municipality of Tiel has included a ban on free parking in their General Local Regulation (APV). This means that sleeping in a campervan on a public parking lot is not allowed.
